3.2.1. Financial Position

GVITE is a not-for-profit organization that supports the advancement of the transportation engineering and planning industry within the Section area, in association with its parent organization, ITE International. The Section area includes all of British Columbia, except Vancouver Island.

The Section's funding generally comes from several key sources, including ITE membership dues, monthly meeting attendance fees, and the ITE Quad Conference (hosted every four years by rotation with the Vancouver Island Section, Washington State Section and Oregon Section). The funds generated at each Quad Conference are typically used to sustain the Section activities in the intermediate years between Conferences. The last Quad Conference held by GVITE was in 2009, with the next one anticipated in 2015.

The Section's major expenses typically include costs associated with our monthly presentations (event venue and food), Section operational costs (including the participation of executive members in the annual Canadian ITE and Quad Conferences), various sponsorship opportunities of the UBC ITE Student Chapter and the BC Interior Chapter, as well as annual awards supporting ITE activities.

3.2.2. Year Status

At the beginning of the 2014 fiscal year, the Section had an account balance of \$8949.45. During the course of 2014, the Section's revenues were \$40,334.04 and the expenditures were \$47,204.45 for a net lossof \$4,673.12. The 2014 GVITE Section financial summary is shown in **Table 2** below.

Notable points with regards to the finance include the following:

- The Section spent a total of \$10,299.19 on eight meetings in 2014, including the Annual General Meeting (AGM).A total of \$10,602.63 was collected from meeting registration fees.
- The Section's operating coststotaled\$165.21, including twoexecutive meetings and web hosting fees. The Section also purchased a new projector for presentations for \$540.49.
- The Section's annual golf tournament raised \$280.20 to support Section and Student Chapter activities.
- The total cost of sending a GVITE representative to the Canadian ITE (CITE) Conference and Annual General Meeting in Waterloo was \$2,542.74.
- The total cost of sponsoring UBC and UBCOstudent activities was \$500.00.
- A portion of money was spent on bookings for the 2015 QUAD conference in May 2015, and additional revenue was received from sponsorships for the QUAD conference.
- ITE International and the ITE Canadian District provided remittance chequestotaling\$135 CAD.

3.4. MONTHLY MEETINGS AND EVENTS

2014 was yet again a busy and successful year for GVITE. Although it did not feature any large ITE conferences such as the Quad Conference in 2009 or the ITE Annual Meeting and Exhibit in 2010, the Section was busy hosting local monthly meetings for the members to attend.

On January 23rd the UBC ITE Student Chapter hosted its Annual Industry Night. The UBC ITE Student Chapter is committed to promoting transportation engineering and building a strong connection between students and industry professionals, and the event was well attended by both students and professionals alike. A portion of the evening was dedicated to presentations by sponsor companies to showcase their areas of expertise, followed by refreshments and networking.



The first meeting in 2014 was held on February 13th, over breakfast. Traffic Signal Team Leader Tim Murphy, a senior transportation project at Delcan presented on a project which utilizes a new roundabout technology developed in the Netherlands called the Turbo Roundabout. The roundabouts are multi-lane roundabouts with spiral road markings and separated circulating lanes that perform better with respect to safety than standard multi-lane roundabouts, while providing the same capacity.





The second Section meeting of the year was held on March 18th over breakfast at the Executive Plaza Hotel (Coguitlam). Carl Johannsen from the City of Coquitlam highlighted Coquitlam's planning approaches that leverage the Evergreen Line as a key transportation and community investment. He also looked at other transit oriented development based initiatives within Coquitlam's new growth areas on Burke Mountain.



On April 30th, 2014the Greater Vancouver Section had a lunch meeting for its third meeting of the year. The Section had Floris van Weelderen, P. Eng., PTOE, and Becky Lai, EIT from MMM Group to present on the Power Street Overpass project. A portion of Powell Street will be realigned to the south to enable the addition of a future new rail track, enhancing capacity and improving access to and from the Port. Dedicated cycling lanes and sidewalks will also be created to improve safety and connectivity to the planned Portside



Greenway running from downtown to Boundary Road as part of the City's Greenways Network. The presentation provided an overview (What, Why, Where, When, Who, and How) of how the project improved safety and navigation through the area for commuters, residents and visitors while enhancing the rail network that supports cargo movement to and from Port Metro Vancouver.

The fourth meeting of the year was held on May 28, 2014 over breakfast. Marhrok Arefi, P Eng., the vice president of Transportation Investment Corporation gave a presentation on the procurement methods, design/development testing, system/operations implementation and customer outreach and engagement program of the Port Mann's all electronic tolling system.





On July 09, 2014, the Section gathered over lunch for its fifth meeting of the year. Lon LaClaire, and Steve Brown from the City of Vancouver gave a detailed presentation highlighting the need for regional transportation investments and the necessity of the Broadway skytrain extension. In the presentation Lon explained how Metro Vancouver had one of the most productive and effective transit networks in North America. He



also highlighted the fact that over the next 30 years, over a million new residents are expected to come to the region, and the time for investment to service these residents is now.

The Section had a technical tour of the Regional Transportation Management Centre in Coquitlam on July 16, 2014. A total of 21 people attended this technical tour which explored the Command Centre as well as the Server Room that houses all the systems. The tour showed how operators control various aspects of the tasks at the RTMC along with an overview of the tools available to them through the system.



The Section also had its first joint summer social event with the Young Professionals in Transportation (YPT) group. This summertime social hangout involved a Vancouver Canadians baseball game at the Nat Bailey Stadium in Vancouver. This familyfriendly event had over 15 people attend and was a great time for everyone.



The Section held its sixth meeting over lunch after the summer break on September 25, 2014. Jeff Moi and David Rawsthrone from the City of Vancouver presented on the Planning and



Construction of the Point Grey Cornwall intersection and the Seaside Greenway, and York Bikeway. This presentation outlined the processes and challenges for planning, consulting on, designing, and constructing over 3.7km of cycling routes and greenways through Vancouver's Kitsilanoneighbourhood including reconfiguring a major arterial intersection and converting an arterial street to a local road.

On October 22, 2014, the Section had its final breakfast meeting at the Holiday Inn at Vancouver Centre. Gary Vlieg, M.Sc, P Eng., from Creative Transportation Solutions explained the importance of evaluating signal operations in the Lower Mainland on an on-going basis. He highlighted thefact that the operating, societal and environmental benefits can justify an on-going program to evaluate signal operations.





The Section invited Dr. Ali Mekky to host an Analytical Transportation Workshop and Emme 4 Course in Vancouver on November 3rdto November 7th, 2014. The five-day workshop, showed the newest analytical methods to reduce traffic and travel problems and devise better ways of moving people and goods. Attendees also learned how to calibrate and test transportation models (EMME4), to evaluate their effectiveness and usefulness for varying requirements and scenarios.





3.5. ANNUAL GENERAL MEETING

The Section held its AGM and Awards Dinner on December 2, 2014 at the Hilton Vancouver Metrotown Hotel in Burnaby. The meeting was well-attended by members, friends and colleagues in the local transportation industry to re-connect and celebrate another successful year in the Greater Vancouver area.



The following awards were presented at the meeting:



Bill Curtis Technical Achievement Award (Project of the Year)

- This award celebrates technical excellence in the field of transportation engineering, design and traffic operations.
- The nominated projects can be a roadway design projects, traffic operation programs as well as transportation studies.
- The selected projects must be substantially implemented or completed in the current calendar year.
- The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitation.



This award was presented to the BC Parkway Improvements project conducted by TransLink and Urban Systems.

Mavis Johnson Award (NEW)

The Mavis Johnson Award is the newest GVITE Award to be presented, starting in 2014.

- This award celebrates technical excellence in the field of road safety.
- The nominated projects should focus on improving road safety. The projects could include safety for vulnerable road users, road safety audits, collision analysis, traffic calming, safe route to school programs, educational campaigns etc.
- The selected projects must be substantially implemented or completed in the current calendar year.
- The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitations.



This award was given to Malahat Highway 1 Safety Improvement Study and Detailed Design conducted by the Ministry of Transportation and Infrastructure and R.F. Binnie Ltd.



Outstanding Professional Award

- This award acknowledges outstanding professional contribution in last two to three years.
- The types of achievement can include in a particular project success, general project management, services to ITE and community, etc.

This award was presented to Chris Hoff from Transport Canada.



Young Professional Award

- This award recognizes demonstration of growing leadership skill and valuable contribution to ITE and/or the transportation engineering and planning profession.
- To be eligible, a candidate must be a young professional working in the transportation profession.
- A young professional is defined as being 35 years of age or younger on January 1 of the current calendar year.



This award was presented to Kati Tamashiro from Bunt and Associates Ltd



Lifetime Achievement Award

• This award recognizes a lifetime of contribution in the transportation industry.

This award was presented to two people this year: Paul Lee from the City of Surrey and Ken Zondervan from Stantec.

As noted in this report, the BC Interior Chapter successfully hosted one mini-conference this year, in the fall of 2014. They also attended and facilitated a half day workshop at the Rural Health Service Research Conference in April of 2014.

3.8. UBC STUDENT CHAPTER

The UBC ITE Student Chapter has had an active year, organizing several major events, as well as participating in events organized by other groups. The UBC Student Chapter hosted theAnnual Industry Night in January 2014. Attendance from both the student and industry communities was high. Two student members also attended the CITE AGM conference in April of 2014. Additionally, UBC ITE student members actively attended GVITE Section meetings as well as a number of student activities and initiatives.

3.10. GVITE WEBSITE

Jpcoming events, job postings and even registration are hosted on the website.

The functionality of the website has not changed in the past few years and most of the work in 2014 was related to upkeep and maintenance. However, the web team has recently grown from 1 to 3, the new members being Sam Young and Jonathan Ho. With the extra resources available, there are plans to enhance and improve the website.

The highest priority at the end of 2014 was to develop a website for the upcoming 2015 ITE QUAD Conference. By the end of the year, the team created a website at

http://www.citevancouver.org/quad2015 and deployed a module to accept abstract submissions online. The team had also successfully developed functionality to display sponsors on the website and was progressing towards a module to handle registrations for delegates, tours, vendors



and sponsors.

It is anticipated that the web team will continue to devote the bulk of its time and resources for the first half of 2015 to support the QUAD Conference. This will involve finalizing the registration page, creating a schedule for the conference programme, and building administration modules to support the organizing committee. There has also been a concerted effort to incorporate elements of social media, such as FaceBook and Twitter, into the design.

For the second half of 2015, there are plans to create a new look and feel for the Greater Vancouver Section website. The new website will likely draw from the work that is done for the QUAD conference, both in terms of layout/aesthetics as well as functionality. While the plans are still preliminary, the web team will likely embark on a staged approach that will involve gathering feedback from the ITE members regarding desired functionality on the website, reviewing existing code, and porting existing functionality and implementing new features. It is anticipated that significant improvements will be made to include social media into the new website.

2. SUMMARY OF ACTIVITIES

The Student Chapter was busy throughout the year, organizing and attending a variety of transportation related events. Below is a summary of the main events that we hosted and attended.

Guest Lectures and Seminars

Evergreen Line Presentation: March 19th, 2014

Senior Project Manager Wendy Itagawa came to UBC and gave a presentation about the Evergreen Line Project on March 19th, 2014. Her presentation highlighted the project planning, procurement methods, design, and ongoing construction processes that were involved with the new SkyTrain line. During the presentation Wendy showed some short videos, including one on the Tunnel Boring Machine that was built specifically for this project. The presentation was concluded by a question and answer session which was well received by the students. A pizza lunch was provided for the event and over 50 students were in attendance. Thank you Wendy for the great presentation!

The Need for Regional Transportation Investment and a Broadway SkyTrain Extension: October 29th, 2014

The UBC ITE Student Chapter invited Lon LaClaire, the Strategic Transportation manager for the City of Vancouver to answer our questions about the proposed Broadway SkyTrain Line and outline a case for regional transportation investments. This is an important topic for students because the proposed SkyTrain may be built all the way to UBC.
In the first half of the presentation, Lon illustrated the positive impacts of regional transportation investments. He showed that transit development is closely related to a city's growing population and economy. From past studies, geographically, all the past growth expands out from major transit routes. It is estimated that over 1 million people will move to Metro Vancouver, and over 500,000 new jobs will be created in the next 30 years. Investment into transportation is crucial to accommodate this growth.

Studies also show that there is a high transit demand in Vancouver. Since the Olympics, Vancouver public transit ridership has increased and continued to grow; comparing to other cities of similar population, Vancouver has the highest transit ridership per capita ratio, and is considerably higher than second-place Portland. Among the regions that have invested in rail rapid transit, Metro Vancouver displays the highest transportation mode shift. This is a good indication that even though rapid transportation projects have high costs, this project is likely well-worth the investment.



Student attendance at Broadway Skytrain Presentation

In the second half of the presentation, Lon discussed the strategic position of the planed Broadway SkyTrain extension. Proposed along Broadway Street in Vancouver, the surrounding area is a major economic region with high residential density. The line would connect the busiest stations of the Expo Line and Millennium Line to the Canada Line, providing an alternate transit route to downtown Vancouver. Studies anticipate that the opening day ridership would be approximately 250,000, which is nearly double the ridership on the recently completed Canada Line and Port Mann Bridge. The high ridership forecast gives the expansion project a very low cost per boarding ratio and reinforces the case for a Broadway Skytrain expansion. The student chapter would like to thank you Lon and the City of Vancouver for the interesting and informative presentation.

Field Trips

Surrey City Centre Tour with Young Professionals in Transportation: September 23rd, 2014

The Surrey City Centre Tour was organized by YPT Vancouver and co-hosted by the UBC ITE Student Chapter. The event was held at the new Surrey City Hall on the evening of Tuesday, September 23rd. The tour began with a brief introduction of the long term visions and goals of the City of Surrey Transportation Division. The introduction focused on the Surrey LRT proposal which is a major factor in the current Metro Vancouver transportation referendum, and how the proposed LRT system would affect the City Centre. In order to help conceptualize the proposed changes, the tour organizers presented posters to illustrate the new road alignments in the downtown core with the LRT in place. Additionally, improved features for active transportation were highlighted such as the ongoing alterations to the street layout in downtown Surrey to better accommodate walking, cycling, and overall quality of life.

The tour itself was oriented around the transportation engineering, planning and the traffic operations divisions at the City of Surrey. The transportation engineering and planning portion of the tour gave students an understanding of what it is like to work in the transportation department for the City. The tour speakers provided insight into how the engineering and planning departments cooperated together as well as how both departments collaborated with city officials. The traffic operations part of the tour focused on the Traffic Control Centre, a room containing 72 screens for viewing CCTV cameras, where vehicle, bicycle and pedestrian traffic

can be observed in real time at intersections throughout the City of Surrey. The computerized traffic signal system allows the staff to monitor and adjust signal intervals to reduce queue times during peak hour congestion or in the event of a traffic accident. Last but certainly not least, the tour concluded with food and drinks which gave students the opportunity to discuss various aspects of the tour with the tour hosts and the YPT event coordinators.

A great thanks to the City of Surrey and their staff who ran the tour, as well as the YPT for collaborating with the student chapter for our first combined event.

Annual Industry Night: January 23rd, 2014

The Student Chapter Industry Night is a popular event with our student members and our industry partners. This annual event is unique because it gives students the opportunity to network and connect with industry professionals in a more casual setting than a typical career fair. This year the event was held in the Chemical and Biological Building on campus to facilitate increased student and sponsor attendance.

Simon Button and Calvin Pin from Student Chapter made the trip to the 2014 CITE Annual Conference in Waterloo, Ontario, where they received the Delta Award on behalf UBC Chapter for the most improved student chapter in the Canadian district. Simon also received the CITE Boulevard Transportation Student Award for a paper on transportation sustainability.

Throughout the conference there was an emphasis on innovation and creating healthy communities. The students had the opportunity to learn about Waterloo's ambitious plans to build a new light-rail system and rival Silicon Valley's technology cluster. The students were also able to learn about Waterloo's German heritage through Oktoberfest celebrations.

SFU City Program: Rethinking Transportation Continuing Lecture Series

Members of the UBC ITE SC attended transportation lectures provided by the Simon Fraser University continuing studies lecture series throughout the year. For example, on September 17th, students attended "Future Livability in Vancouver" by Gil Penalosa from 8-80 Cities, where Gil described how we can design cities and their transportation systems for people of all ages. External events such as these provide great learning opportunities for students and enable them to broaden their transportation knowledge.

The events at the start of the year are a great way to become acquainted with new members, and events at the end of the semester are a great way to unwind and celebrate a job well done.

3. COLLABORATION WITH OTHER STUDENT GROUPS

The UBC ITE SC strived to increased engagement within the Civil Engineering department as well as with other groups in different disciplines on campus and within the community. This year, an effort was made to target more students by promoting events through other organizations, classroom announcements, the UBC ITE SC website, posters, and Facebook.

School of Community and Regional Planning (SCARP) Student Associations

Transportation engineers and planners often work together on projects, and we thought it would be a good idea to collaborate with the SCARP Student Association this year. We are working towards hosting our own combined event this spring, and the two clubs have been promoting and supporting each other's events.

UBC Civil Club and Canadian Society of Civil Engineers (CSCE) Student Chapter

We maintained communication and positive relationships with the Civil Club and the CSCE Chapter, two of the most prominent civil engineering student groups at UBC. We are currently working with many civil clubs to host a combined thank you dinner for our sponsors. Sharing resources, information and contacts with these organizations has been mutually benefitted for all members and we will continue to work together in the coming year.

Young Professionals in Transportation (YPT) Vancouver Sections

The Young Professionals in Transportation is an industry chapter where young individuals in the transportation field can meet, socialize and learn about transportation projects in the region. We had our first combined event with YPT this year and it was a great success. Events with YPT allow our student membership to meet engineers and planners who are in the industry, and this has resulted in new connections between the groups.

4. Advertising and Sponsorships

This year the Student Chapter redesigned its' marketing strategy to attract more student interest and industry sponsorships. The following is a summary of the work we completed.

Student Advertising

We continued to maintain our traditional advertising programs such as classrooms announcements, posters and email mailing lists throughout the year. However, in order to improve our communication with our members, we developed a new Facebook page and implemented monthly newsletters. The Facebook page and events enable us to connect with prospective members and communicate effectively with existing members. The new monthly newsletters include information about our coming events and meeting schedules, as well as our events being held by our partners (SCARP and YPT) and other transportation related events in the area. The implementation of a new Facebook page and monthly newsletters has enabled us to become the go to place for transportation knowledge and event information on at UBC.

Industry Advertising & Sponsorships

A rebranding process was undertaken with the assistance of UBC Applied Science Faculty Development Advisor Jonathan Doan. Several meetings were conducted to examine the current state of the club and potential new marketing strategies that could be adopted.

The student chapter then designed new marketing documents and sponsorship packages. The new marketing brochure explains the mission of the student chapter, what services and education opportunities we provide for students and how our sponsors can collaborate with us. Another part of the new marketing strategy was to review and update the sponsorship levels and packages. Based on the advice we received from Jonathan and our funding requirements for the coming year we adjusted our sponsorship packages accordingly. This resulted in the addition of a "Lead" sponsorship position, valued at \$3000, who would receives benefits such as participating in students meetings, giving an exclusive company presentation and increased advertising. This lead sponsorship would go exclusively towards sending a student chapter team to the Traffic Bowl competition and Annual CITE conference. We have yet to receive a Lead sponsor for this year, but we have seen an increase in sponsorships for the current year. The new marketing document and sponsorship levels are shown in Appendix B.

4. BUDGET

The UBC ITE SC has continued to invest in events and activities to promote our student chapter and the field of transportation engineering. The section below summarizes our expenses and Industry Night sponsorship revenues in 2014.



On December 31, 2014, the UBC ITE SC closed with a balance of \$2275.25.

The Student Chapter spent a large portion of our budget (over \$2300.00) sending students to the CITE Conference in Waterloo this year. While this is beneficial for the individual students who attend the conference and the chapter as a whole, this level of spending without increased sponsorships is not sustainable. We are currently in the process of attaining additional funding to send a team of students to the Traffic Bowl and CITE Conference in 2015.

5. CONCLUSION

In conclusion, the 2014 year was a successful year for the UBC ITE Student Chapter. The chapter organized many events including guest lectures, field trips and our annual Industry Night. The chapter also participated in other events including the annual CITE conference in Waterloo and local transportation events held by the GVITE, YPT Vancouver and SFU Continuing Studies. Membership and participation in the club remained high though out the year. In short, the chapter achieved its goals of promoting transportation engineering and connecting students with transportation engineering and planning industry.

However, there is always room for improvement, and next year's chapter will have more work to do. Focus areas to improve upon for the next year include the following;

- → Cooperation with other student groups and organizations: Plenty of progress was made to connect with other transportation and student groups this past year. We believe that these connections are important to diversify the experience that our student members receive, and a priority for next year will be to renew and reinforce this cooperation.
- → Start of the year: Organization at the start of the academic year in September is one area for improvement. It often takes a few weeks to host introductory presentations and over a month to select the executive council. This year the outgoing president with make an effort to prepare the incoming executive council for the coming year so they can begin chapter operations shortly after returning to school.
- → Relationship with sponsors: The student chapter is thankful for our industry sponsors and partners, but there is room for improvement when it comes to connecting with our sponsors throughout the year. The chapter will work towards maintaining contact with our sponsors throughout the year and perhaps holding multiple events where our student members can meet with our sponsors.

The UBC ITE Student Chapter would like to thank all of our sponsors and partners whose generous support made another year of chapter activities possible. We would also like to thank our advisors Professor Tarek Sayed and Mr. Clark Lim, whose help and advice was a great resource throughout the year.

On June 25th, the CITE Student Chapter members helped organize a bicycle safety training event for everyone at Dr. Gordon Lovegrove's STS Lab. The event relied on the help of UBC Okanagan's very own UBCycles bicycle sharing program, which provided the bicycles and helmets that made this event possible. The Bike Safety Training event was planned in preparation for test riding the STS Lab's very own instrumented probe bicycle (IPB), a bicycle outfitted with a multitude of sensors. Developed at the STS Lab, the IPB is a part of a research project that aims to improve infrastructure planning and design for cyclist comfort and safety. The UBC Okanagan ITE student chapter advisor, Dr. Gordon Lovegrove, took on the role of skills and safety instructor in this bike safety training event. Students got a chance to learn the rules of the road while riding around UBC Okanagan. The training will help the team become more comfortable with riding the IPB, and hopefully has encouraged more students to embrace cycling as a fun and healthy transportation option.

3.5 Student Presentation Contest

In April 25th, the chapter organized an Annual Student Presentation Contest. The Theme of the contest this year was "Current Transportation Engineering Issues". The objective of the contest is to encourage students to engage more in ITE. In addition, it provided opportunity for the students to present in front of transportation engineer's experts and get feedback from them. Members of the CITE BC Interior Chapter attended the as judges and provided valuable evaluation for the participants. At the end of the event, the winners were announced and the prizes were awarded by the CITE president, Mr. Peter Truch.
