

2.1 Agenda

2.3 Minutes of the 2014 AGM

The minutes from the 2014 Annual General Meeting were reviewed. A summary of the decisions is provided below.

The 2015 Executive Committee has accomplished two of the main motions brought forward from discussions at the 2014 AGM, including a minimum operating balance of \$6,000 and minimizing the number of "walk-ups" to scheduled events.

Two motions carried forward for the upcoming calendar year include sponsoring the Carleton University Student Chapter of CITE or using extra funds to sponsor student scholarships and awards, and to determine if members of the Section are interested in forming a Conference Committee for hosting the 2017 CITE National Conference in Ottawa.

Motion to accept the 2014 AGM Minutes made by Valerie McGirr and seconded by Ian Borsuk. Carried.

2.4 President's Report

Gord Scobie concluded the 2015 National Capital Executive Committee by reviewing the events held during the 2015 calendar year. He noted the addition of Anthony Kwok to the 2015 Executive Committee as the Technical Representative. The other members of the Executive have continued their progression of roles as planned.

His recommendation for the 2016 Executive Committee is to continue to vary the venues to draw interest from attendees to experience different atmospheres associated with the venues. Furthermore, Gord suggested for the new executive to organize a free social or networking event to encourage the transportation community to show their support the local CITE Chapter, while continuing to host between 4-5 events a year.



From Gord's attendance to the CITE Annual Conference in Regina, he noted how the Executive won the Delta Award for 2014. He described his experience at the conference and had a few notes. Gord recommended Carleton's CITE Student Chapter become involved with the Traffic Bowl competition, an event held at the annual Conference which pits teams from various academic institutions in a Jeopardy-like competition on transportation-related questions. Furthermore, Gord noted that the Executive Committee of CITE will be publishing a manual for running the local chapters and outlining the overall vision of the organization.

Motion to accept the 2015 Presidents Report made by Andrew Harte and seconded by Anthony Kwok.

Discussion:

Those in attendance were in agreement with trying different venues add variety of cuisine and location for those attending. This would increase the diversity of those who could attend based on their offices located in different parts of the City. Additionally, organizing extra social/ networking events could help improve the profile of CITE in the National Capital Region by hosting events that require little preparation. The attendees also agreed to continue to promotional discount to events for government staff and student admissions.

Anthony Kwok has agreed to approach the Carleton CITE Student chapter to create a team to compete in the upcoming 2016 Traffic Bowl.

2.5 Treasurer's Report

Ian Borsuk presented the 2015 Treasurer's Report. The bank balance as of December 15th was \$6,289.45, with \$420 in cash on hand and \$301.50 in accounts receivable. The bank balance is up \$165.68 from the end of 2014.

Motion to accept the Treasurer's Report made by Valerie McGirr seconded by Andrew Harte. Carried.

Discussion:

Valerie McGirr inquired whether the Section had donated to ITE's leadership program which was looking for a donation of \$5 for each registered member of the local section. No donations have been provided to date to ITE for the leadership program. Valerie McGirr will look into the ITE Leadership Program.

Andrew Harte suggested to use the extra funds available exceeding the \$6,000 operating balance, the Section should look into donating for scholarships. Previously, the Braaskma Transportation Engineering Scholarship was brought forward as a scholarship to support. The attendees decided to contribute \$500 on behalf of the National Capital Section to the Braaksma Scholarship and use another \$500 to subsidize the government staff and student discounts for upcoming events.



Motion to accept the use of funds to support the Braaskma Scholarship and subsidize the event discounts made by Valerie McGirr seconded by Anthony Kwok. Carried.

2.6 Technical Representative's Report

Anthony Kwok presented the Technical Representative's Report. There were six events held in 2015 which included four luncheons, a Student Presentation Competition, and our Annual General Meeting. The following table details the events.

Andrew Harte led a discussion regarding suggestions for 2016 which included administrative changes, ideas of potential events, and Section initiatives. 3 2015 National Capital Section President's Report

During 2015, the National Capital Section (NCS) executive remained intact from the previous year, with the addition of Anthony Kwok as our Technical Representative. This was great for our local Chapter as everyone had a good sense of what each role required.

Similar to our previous year, we focused on delivering high quality venues and programs in an effort to provide our members with an outstanding ITE experience. We hosted a total of four technical luncheons at two familiar venues (the downtown Marriott Hotel and Robbie's Italian Restaurant) and one new venue (Murray Street Kitchen). The new venue provided great food and a comfortable atmosphere; however, some technical glitches (e.g. audio, viewing angles, etc.) could have been refined. Despite the "not so perfect" experience at the new venue, I strongly encourage our executive to continue exploring new venues. It has been expressed to me by some of our attendees that they enjoy the venue changes, as it encourages them to try new things and it provides an opportunity for luncheons to require less travel time.

Due to our annual sponsors and our increase awareness of expenditures, we managed to have a balanced budget for 2015, with a closing balance within \$200 of our previous year's closing balance.

Looking forward, I encourage the executive to promote a greater student participation (e.g. Traffic Bowl), a social/networking event (e.g. golf tournament, wine/cheese, etc.) and possibly 1-2 additional luncheons.

CITE National Conference

This year, I had the pleasure of attending the national CITE Conference in Regina, Saskatchewan to accept our chapter's Section Activities Delta Award for our hard work in 2014. Upon receiving this award, many executive members from other chapters were keen to learn from our previous year's success. Of particular interest, was how we have adopted Eventbrite as a means of managing our events.

Aside from the many interesting sessions/presentations at this conference, the annual east vs west street hockey tournament was a hit! As a natural defenceman (normally a goalie), I didn't contribute to any goals but if I remember correctly, team east won by a goal or two.

At the close of the conference, the National Executive hosted the Student Traffic Bowl. This Jeopardy style event was a fun way to get students involved in CITE and I was surprised that our local student Chapter (Carleton) was absent. After experiencing this event, I believe the NCS



Executive should promote this event to our local student Chapter and encourage them to participate in next year's national conference in Kelowna, BC.

CITE National Strategic Plan Review Session

In November, I participated in a formal workshop/brainstorming session with the National CITE Executive and a number executive members, representing the majority of local section Chapters. This session was very well organized and a lot of great ideas for CITE as a whole to tackle came from it, with involvement from everyone who attended.
