3.2.1. Financial Position

GVITE is a not-for-profit organization that supports the advancement of the transportation engineering and planning industry within the Section area, in association with its parent organization, ITE International. The Section area includes all of British Columbia, except Vancouver Island.

The Section's funding generally comes from several key sources, including ITE membership dues, monthly meeting attendance fees, and the ITE Quad Conference (hosted every four years by rotation with the Vancouver Island Section, Washington State Section and Oregon Section). The funds generated at each Quad Conference are typically used to sustain the Section activities in the intermediate years between Conferences. The last Quad Conference held by GVITE was in 2015, with the next one anticipated in 2019.

The Section's major expenses typically include costs associated with our monthly presentations (event venue and food), Section operational costs (including the participation of executive members in the annual Canadian ITE and Quad Conferences), various sponsorship opportunities for the UBC ITE Student Chapter and the BC Interior Chapter, as well as annual awards supporting ITE activities.

3.2.2. Year Status

At the beginning of the 2016 fiscal year, the Section had an account balance of \$9,046.16. During the course of 2016, the Section's revenues were \$14,576.35 (which excludes the transfer from US dollar account) and the expenditures were \$16,928.83 for a net loss of \$2,352.48. It should be noted that the revenue related to Section Dues for 2016 are still outstanding.

Key highlights of the financial statement include the following:

- The Section spent a total of \$11,528.13 on seven meetings in 2016, including the Annual General Meeting (AGM). A total of \$9,695.00 was collected from meeting registration fees.
- The Section's operating costs totaled \$1,066.48, mostly including two executive meetings, purchase of a new camera and projector, web hosting fees, etc. The Section also sold a used projector to partially fund the replacement of a new one for \$200.00.
- The Section's annual golf tournament raised \$117.29 to support Section and Student Chapter activities.
- The total cost of sending a GVITE representative to the Canadian ITE (CITE) Conference and Annual General Meeting in Kelowna was \$1,911.51.
- The total cost of sponsoring UBC and UBCO student activities was \$500.00.
- A portion of the proceeds from the organization of the CITE Annual Conference in Kelowna based on GVITE members participating on the conference organizing committee.
- Sections fees for 2016 are still outstanding from CITE / ITE International.

3.4. MONTHLY MEETINGS AND EVENTS

2016 was yet again a busy and successful year for GVITE. Apart from the 2016 CITE Conference which was successfully held in Kelowna with the Interior Chapter, the Section was busy hosting local monthly meetings for both members and non-members alike to attend.

The first event of the year was the annual Student Industry Night, held on February 11th by the University of British Columbia's ITE Student Chapter. The event took place at the Engineering Student Centre and was well-attended by both students and industry professionals. The event provided a great opportunity for students to network with professionals and for companies to promote transportation engineering and showcase their areas of expertise.







The second event of the year was a breakfast meeting held on March 30th. Clark Lim, Principal of Acuere Consulting, provided a very interesting presentation on the Internet of Transportation Things. The presentation outlined the technological advances of the transportation industry and

where we might be heading as a professional discipline.

On April 4th, the Greater Vancouver ITE and CSCE Vancouver co-hosted a presentation on the George Massey Tunnel Replacement Project. Daniel Belisle (BC MoTI) and Joost Meyboom (WSP | MMM) provided an update on the project scope and results of preliminary studies for the project. Both Daniel and Joost are currently working on the project as owner's engineers.



On May 26th, Alex Bigazzi from the University of British Columbia provided members with a presentation on air pollution uptake by active travellers. This presentation focused mainly on the pollution risks for active travellers based on several recent studies on traffic-related air pollution uptake by cyclists. The presentation also provided guidance on pollution-conscious bicycle and pedestrian network design.










From June 5-8, several GVITE members attended the CITE Annual Conference in Kelowna, BC, including four executive members. The conference was hosted by the BC Interior Chapter and was a resounding success. The three days of programming included interesting presentations, technical tours, and social events. We are pleased to say that at the awards presentation GVITE was the recipient of the CITE Section Activities Award for the second consecutive year!



The Greater Vancouver Section of ITE had a busy couple months following the summer break with two meeting and our annual golf tournament. The sixth meeting was held on September 7th to kick off the second half of the year. Raheem Dilgir, President of TransSafe Consulting, presented on BC's road safety strategy. This presentation included an overview of the evolution of the strategy and then focused on the work of the Safe Roads and Communities Working Committee.



On October 6th, Michelle Babiuk and Geoffrey Ho from TransLink presented on the 2015 Transit Service Performance Review (TSPR). This presentation provided an overview of the metrics included in the TSPR and demonstrated how the document can be used to inform municipal land use and transportation planning processes as well as for transit service design.



3.5. ANNUAL GENERAL MEETING

The Section held its AGM and Awards Dinner on December 7, 2016 at the Hilton Vancouver Metrotown Hotel in Burnaby. The meeting was well-attended by members, friends and colleagues in the local transportation industry to re-connect and celebrate another successful year in the Greater Vancouver area.





The following awards were presented at the meeting:



Bill Curtis Technical Achievement Award (Project of the Year)

- This award celebrates technical excellence in the field of transportation engineering, design and traffic operations.
- The nominated projects can be a roadway design projects, traffic operation programs as well as transportation studies.
- The selected projects must be substantially implemented or completed in the current calendar year.
- The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitation.



This award was presented to TransLink, VIA Architecture and Graham Construction for the Main Street SkyTrain Station Upgrade.

Mavis Johnson Award

- This award, initiated in 2014, celebrates technical excellence in the field of road safety.
- The nominated projects should focus on improving road safety. The projects could include safety for vulnerable road users, road safety audits, collision analysis, traffic calming, safe route to school programs, educational campaigns etc.
- The selected projects must be substantially implemented or completed in the current calendar year.



• The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitations.

This award was presented to BC MoTI, PBX and IBI Group for the Variable Speed Limit System.



Outstanding Professional Award

- This award acknowledges outstanding professional contribution in last two to three years.
- The types of achievement can include a particular project success, general project management, services to ITE and the transportation community, etc.

This award was presented to Patrick Livolsi from BC MoTI.



Young Professional Award

- This award recognizes demonstration of growing leadership skill and valuable contribution to ITE and/or the transportation engineering and planning profession.
- To be eligible, a candidate must be a young professional working in the transportation profession.
- A young professional is defined as being 35 years of age or younger on January 1 of the current calendar year.



This award was presented to Jared Duivestein from Parsons.



Lifetime Achievement Award

• This award recognizes a lifetime of contribution in the transportation industry.

This award was presented to Julian Rozental of J. Rozental Consultancy.


