4. Section Activities

CITE-SK typically organizes two (2) full-day Technical Session per year during the Spring and Fall, hosted in Regina and Saskatoon, respectively. In 2016, CITE-SK also hosted two (2) ITE webinar sessions concurrently in Saskatoon and Regina.

4.1. Unsignalized Intersection Improvement Guide Webinar (Nathalie / Charlie / Tanya)

CITE-SK hosted the ITE webinar, "Unsignalized Intersection Improvement Guide" on February 4, 2016 in Saskatoon (Dillon Consulting Limited offices) and Regina (Ministry of Highways and Infrastructure boardroom).
