3.2.1. Financial Position

GVITE is a not-for-profit organization that supports the advancement of the transportation engineering and planning industry within the Section area, in association with its parent organization, ITE International. The Section area includes all of British Columbia, except Vancouver Island.

The Section's funding generally comes from several key sources, including ITE membership dues, monthly meeting attendance fees, and the ITE Quad Conference (hosted every four years by rotation with the Vancouver Island Section, Washington State Section and Oregon Section). The funds generated at each Quad Conference are typically used to sustain the Section activities in the intermediate years between Conferences. The last Quad Conference held by GVITE was in 2015, with the next one anticipated in 2019.

The Section's major expenses typically include costs associated with our monthly presentations (event venue and food), Section operational costs (including the participation of executive members in the annual Canadian ITE and Quad Conferences), various sponsorship opportunities of the UBC ITE Student Chapter as well as annual awards supporting ITE activities.



3.2.2. Year Status

At the beginning of the 2017 fiscal year, the Section had an account balance of \$13,002.38. During the course of 2017, the Section's revenues were \$ 18,230.07 and the expenditures were \$21,422.77 for a net loss of \$3,192.70. The 2017 GVITE Section financial summary is shown in **Table 2** below.

Notable points with regards to Section finances include the following:

- The Section spent a total of \$15,088.42 on eight meetings in 2017, including the Annual General Meeting (AGM). A total of \$13,150.00 was collected from meeting registration fees.
- The Section's operating costs totaled \$747.31, including one executive meeting, purchase of HDMI cable and AGM Award plaques, etc.
- The Section's annual golf tournament raised \$529.92 to support the Section activities.
- The total cost of sending a GVITE representative to the Canadian ITE (CITE) Conference and Annual General Meeting in Toronto was \$2,973.31.
- The total cost of sponsoring UBC Student Chapter activities was \$500.00.
- ITE International and the ITE Canadian District provided remittance cheques totaling \$2,731.50 CAD.

3.4. MONTHLY MEETINGS AND EVENTS

2017 was yet again a busy and successful year for GVITE, with the Section hosting several local monthly meetings for the membership to attend.

The first event of the year was the annual Student Industry Night, held on February 7th by the University of British Columbia's ITE Student Chapter. The event took place at the Engineering Student Centre and was well-attended by both students and industry professionals. The event provided an excellent opportunity for students to network with professionals and for companies to promote transportation engineering and showcase their areas of expertise.

The second event of the year was a lunch meeting held on March 1st. Floris van Weelderen from WSP provided insights into current practices and recent innovations for completing cycling safety assessments of a multi-use trails, such as the scenic 40 km long Valley Trail network in Whistler. In addition, the findings of an investigation into the operational characteristics of power assisted bicycles, electric scooters, ebikes or other Personal Mobility Devices (PMVs) were shared. This assessment enabled the Resort Municipality of Whistler to develop a policy for allowing e-bikes and



other emerging PMVs on non-motorised municipal facilities, such as sidewalks, bike lanes, multiuse pathways and trails within its jurisdiction while restricting others to the street.



The first event of spring was held on March 29th, and consisted of a breakfast meeting where Paul Lee, the Acting Project Director of Surrey Light Rail Transit (LRT) at the City of Surrey, shared his experience and the City's perspective on TransLink's proposed LRT system in Surrey. The project is currently in the planning and design phase, and upon completion will be the region's first at-grade, urban-style rail transit system. Paul highlighted how the LRT is the catalyst in a broader plan to help shape sustainabile development in the City over the course of several decades.

The second event of the spring was held on April 18th, and coincided with the one-year anniversary of when TransLink first closed the faregates at all SkyTrain Stations and facilitated wide-spread adoption of the Compass Card by the general public. Tom Prestia and William Hui, systems engineers at TransLink who worked on the Compass Card, delivered a presentation a customized presentation that was centered around the questions submitted in advance by GVITE members. Tom and William described many of the key features of the Compass Card system, and noted that as of the time of the





presentation nearly 2 million Compass Cards have been issued and that the Compass Card is used to pay for over 95% of all fares. Questions from the GVITE community focussed heavily on applications, and covered topics including fare calculation methodology, potential future fare policy and refinements to the existing transit zone system, use of other media such as credit cards for fare payment, and data collection and analytics, including potential for open data.

The third event of the spring quarter was a lunch meeting on May 16th with Clark Lim of Acuere who expanded on some of the themes presented in his Internet of Transport Things (IoT2) talk from last year. Throughout history, man's innovations resulted in key technologies that represent a marker for each human era. The constant evolution of technologies combined with fundamental needs creates industries with a cycle of birth, peak and death. "Disruptive" innovations are the "engines" of these cycles and the discipline of engineering is the source of many of these "disruptive" innovations. However, the rate of innovation and change is approaching unprecedented levels. Innovations, such as autonomous vehicles, big data, and artificial intelligence, have the potential to significantly change the transportation engineering industry.



Clark's presentation led the discussion as to "Whether the transportation industry will become a victim of disruption, or be able to change and adapt to the future? If so, what can we do to transform our industry and our profession?"

The final event before the summer break was a breakfast meeting on June 6th. Nancy Baggio, of the Vancouver Airport Authority discussed the YVR 2037 Master Plan, the authority's 20-year plan for guiding the development of the Vancouver International Airport. This presentation discussed all aspects of the Master Plan, including the consultation process, terminal plans, airside and airspace, ground access, the natural environment, community amenities and land use planning.

Over the summer break, the Greater Vancouver Section of ITE hosted the 16th Annual GVITE Golf tournament on Thursday, June 22nd at the Burnaby Mountain Golf Course. The weather was great with many golfers participating in the tournament and dinner, and prizes given out. Following the success of last year's event. а trivia auestion with а transportation-related topic was asked at the end of every hole.

The first event of the fall was a lunch meeting held on September 13th, with Paul de Leur of and Nicholas Moss of the Insurance Corporation of British Columbia (ICBC), who presented the results of the recent update to the ICBC Road Safety Benchmarks. The previous benchmarks were compiled ten years ago, and the update provided a new set of benchmark road safety metrics, based on 2011-2015 crashes and covering a range of







intersection types and environments. These updated benchmark values are used to identify high-



risk locations by facilitating comparisons using sets of average values for crash frequencies, rates, and severities. The benchmarks provided enhanced an framework for the systematic and proactive identification of intersections for safety improvements, including those that may be eligible for funding under ICBC's Road Improvement Program, now in its 27th year.

The second technical event of the fall was a breakfast meeting on October 17th. Kenedee



Ludwar and John Babineau of the BC Ministry of Transportation and Infrastructure discussed the implementation of BC's Variable Speed Limit (VSL) system on three major rural highways. Road side sensors collect data on weather and road conditions, and vehicle speeds, and the Ministry uses this information to remotely adjust speed limits accordingly. Kenedee and John discussed the challenges of automating speed limit recommendations, and an upcoming application of a VSL system in an urban highway context as a congestion management tool.

3.5. ANNUAL GENERAL MEETING

The Section held its AGM and Awards Dinner on November 28, 2017 at the Hilton Vancouver Metrotown Hotel in Burnaby. The meeting was well-attended by members, family, friends and colleagues in the local transportation industry to reconnect and celebrate another successful year for the Greater Vancouver Section.

The following awards were presented at the meeting:



Bill Curtis Technical Achievement Award (Transportation Project of the Year)

- This award celebrates technical excellence in the field of transportation engineering, design and traffic operations.
- The nominated projects can be a roadway design projects, traffic operation programs as well as transportation studies.
- The selected projects must be substantially implemented or completed in the current calendar year.
- The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitation.



This award was presented to the City of Vancouver for the West End Parking Strategy. This project's main intent was to free up on-street parking in the West End for visitors a nd short-term trips by moving long term residential parking into off-street facilities.

Mavis Johnson Award (Road Safety Project of the Year)

- This award celebrates technical excellence in the field of road safety.
- The nominated projects should focus on improving road safety. The projects could include safety for vulnerable road users, road safety audits, collision analysis, traffic calming, safe route to school programs, educational campaigns etc.
- The selected projects must be substantially implemented or completed in the current calendar year.
- The selection criteria include technical complexity and innovation, societal importance, sustainability, quantity of work and budget/time limitations.

This award was given to the City of Vancouver, Parsons and TranSafe Consulting Ltd. for Protected Intersection Installation at Burrard Street & Pacific Street. As part of a larger project to rehabilitate the historic Burrard Street Bridge and restore pedestrian access to the east sidewalk, the intersection

with Pacific Street at the north end of the span was reconfigured with a combination of spatial and temporal separation between modes to eliminate conflicts between people walking, cycling and driving.



Outstanding Professional Award

- This award acknowledges outstanding professional contribution in last two to three years.
- The types of achievement can include in a particular project success, general project management or technical work, services to ITE and community, etc.

This award was presented to Stephanie McNeely, P.Eng. from the City of Vancouver.

Young Professional Award

- This award recognizes demonstration of growing leadership skill and valuable contribution to ITE and/or the transportation engineering and planning profession.
- To be eligible, a candidate must be a young professional working in the transportation profession.
- A young professional is defined as being 35 years of age or younger on January 1 of the current calendar year.

This award was presented to Ross Kenny, P.Eng. from the City of Vancouver.

3.6. 16TH ANNUAL GOLF TOURNAMENT

The purpose of the golf tournament is to raise money to sponsor UBC student chapter activities. The weather was great with over 18 golfers participating in the tournament and dinner, with many prizes given out.

3.7. MEMBERSHIP SURVEY

The GVITE Executive often receives feedback about the events that the Section organizes, as well as suggestions about events that the Section should organize. In response, in 2017 the Executive launched the first-ever online member survey, to solicit feedback about how the section is run, and what opportunities exist for improvement. To encourage participation, a \$50 gift certificate prize was awarded to a randomly-selected participant. The feedback confirmed that the memberships favoured events are breakfast or lunchtime technical seminars, with a preference for relatively central locations and moderate costs. Member feedback highlighted some of the different challenges that public- and private-sector professionals have in obtaining permission to register for events, and the Section is looking to ensure continued participation from professionals in both



sectors (as well as students). Other feedback included an interest in technical tours, improved social media presence, and preferences for presentation topics.

3.8. BC INTERIOR CHAPTER

The BC Interior Chapter's vision is to support all ITE members and transportation professionals in the interior area of the Province of British Columbia (bounded approximately on the west by Hope, on the east by the BC/Alberta Border, on the north by Prince George, and on the south by the Canada/US border). As noted in this report, the BC Interior Chapter successfully hosted a mini-conference in the fall. In 2017, the BC Interior Chapter elected to establish their own Section, and is currently working with CITE to facilitate this process. The GVITE Executive is supportive of the Chapter's initiative, and has worked with the Chapter to formalize the geographic boundaries of the two organizations.

3.9. UBC STUDENT CHAPTER

The UBC ITE Student Chapter has had an active year, organizing several major events, as well as participating in events organized by other groups. The UBC Student Chapter hosted the Annual Industry Night in February 2017. Attendance from both the student and industry communities was high. Three student members also attended the ITE / CITE Annual General Meeting & Exhibit in July/August of 2017. Additionally, UBC ITE student members actively attended GVITE Section meetings as well as a number of student activities and initiatives.

The Chapter continued to be supported by Dr. Tarek Sayed as the Chapter Advisor and Mr. Clark Lim as the Assistant Chapter Advisor. The 2017 UBC ITE Student Chapter Annual Report is appended to this document as **Appendix C**.

3.10. UBCO STUDENT CHAPTER

The chapter successfully hosted student presentation contest, Industry Night, and a mini Traffic Bowl competition in 2017. Three student members also attended the ITE / CITE Annual General Meeting & Exhibit in July/August of 2017.

(Bucents) Fatal crash outcomes usually depend upon a number of factors which interact and lead to clasth. We need to consider the role that all the elements play in a fatal outcame — the road and madside, the vehicle, the speed limit and behaviour of the nod unces involved. A legical framework, which examines thates road safety elements and their interactions, is essential to enable practitioners to develop their thinking and understanding anound risk and countermeasure possibilities. It includes elements that are proactive in nature, such as Land Use Planning in addition to elements that are reactive, such as Pask-Crash Response. The Safe System approach provides this framework, it is derived from the work of the Swedish Read Authorby and Read Safety Agencies in the Retherlands are has been adopted as the basis for read safety activity in Victoria, Australis since 2003. It has also been adopted as the foundation for Canacia's RSV 2025 and by several provinces and cities. A recent report from the Morid Resource: Institute revealed that countries that have adopted a Safe System approach have both the lowest rates of fatalities per 100,000 population and the fastest rate of change in fistality levels. This presentation will cover the principles of the Safe System approach, in addition to the benefits of moving to this comprehensive and integrated approach.

About the Presenters:

Mavis Johnson was the Founder and President of the Canadian Traffic Safety Institute. She has been involved in road safety in the UK and Canada for almost 50 years. In January 2017 she became the Community Development Advoor to the Traffic Jinjury Research Foundation. She continues to take a leadership role in road safety arrass Canada and has been actively involved in developing integrater road safety strategies in several roles and provinces. In the last the years she has undertaken many international road safety projects, particularly in low and middle income countries. Her major focus is in strategic road safety planning and the Safe System approach. Mavis has knowledge and expertise in all areas within the Decade of Action for road safety and understands the importance of all the components working fammolisculy to deliver pastitive road safety functiones.
