## 2.5 2017 Treasurer's Account Summary

Eric Stewart presented the 2017 Treasurer's Report. The bank balance as of December 31<sup>st</sup>, 2017 was \$6,566.53, with \$185 in cash on hand. The \$300 in accounts payable from 2016 was included in the bank balance since the cheque can no longer be cashed. The 2017 closing balance has increased by \$1,883.55 from the 2016 calendar year.

Discussion:

- R. Vastag raised the idea of providing financial assistance for out of town guest speakers, which could include accommodations and transportation costs.
- D. Green raised the idea of hosting another seminar/ training event based on previous successes. V. Skelton, Chair of the CITE Training Committee, mentioned that CITE is in the process of rolling out training programs for the section chapters across Canada. Ideas that were generated from the discussion included training on complete streets, roadway safety, traffic calming, and the new Canadian Capacity Guide software being developed in partnership with PTV. The CITE Training Committee would need assistance from the local executive to find a local venue and for the advertising of the event.

The technical presentations covered a range of topics including long-range transportation trends, LRT planning, cycling design, and traffic safety. The *Student Presentations Competition* had four (4) groups presenting which represented approximately 20 students from Carleton University and their classmates, in addition to 6 local CITE members who attended.

Several potential presenters have been identified for 2018. The first presentation of the year has been confirmed on the Transportation Impact Assessment Guidelines and scheduled in January. Additional presenters have been identified on rail safety and the implementation of transit to support suburban development.



New venues were considered with an aim to reduce the costs and ticket prices for the event. The Fox and the Feather had the lowest price and also had the highest attendance of all the events. The Arc Hotel and Courtyard continued to provide high quality meals for a higher cost. A continued effort to identify venues with a good balance between quality of the venue and low costs may be beneficial in future years.

Member discounts were continued this year for both general members as well as an additional discount for government and student discounts. The government and student member discounts accounted for less than 10% of all ticket sales, while general member discounts accounted for 34% of all ticket sales.
