The May 13 meeting was noteworthy as our first ever online event and had almost 200 simultaneous viewers making it the largest event in our section's history. In addition to being an interesting topic, it showed there was strong interest in locally relevant technical content delivered online.

In addition to the above presentations our board also meets on the second Tuesday of every month to organize our efforts to provide section activities and carry out various administrative activities. On July 18, our board also conducted our annual calendar planning session in which we brainstorm ideas and identified which should be prioritized for the upcoming year.

Student/Younger Member Support

Topic: On Demand Transit Service

Our policy for the last couple of years has been to provide five free student registrations at each of our monthly luncheon to expose students to the Section and provide an opportunity to network with professionals in the industry. Registrations are administered by our student chapter

at the University of Alberta, which also provides an ongoing point of contact with the chapter. Due to Covid we only hosted two luncheons in 2020, but look forward to continuing the practice in the future.

We also support our student chapter's annual paper competition by contributing financially to their prize pool and helping to recruit judges from industry. The paper competition continues to foster interest in transportation among students and the chapter consistently receives a number of high quality submissions.

Application of Technical Knowledge

Local transportation challenges and projects tend to feature prominently in our luncheons and webinars. We prefer topics that discuss an actual project, especially projects within Alberta or Canada, and are not purely theoretical or research based. All seven meetings in 2020 discussed a project within the boundaries of the Northern Alberta section. These projects include issues that have generated debate at the local and national level, including parking requirements, active transportation, and on demand transit. We also hosted an event in June, which we typically don't do, to showcase local responses to transportation issues caused by the pandemic. Our meetings include time for Q&A after the presentation and the discussion is often interesting and edifying.

Networking Events

The Northern Alberta Section hosted an end-of-year online social in December. Despite our initial concern that the online format would be very awkward, the social was a great success with over 20 participants. We started by randomly mixing attendees into breakout rooms with some icebreaker questions, which resulted in great random conversations similar to what you would experience at a conference or luncheon; several people remarked afterwards that the time flew by very quickly. We also held several rounds of trivia with prizes (gift cards to a local business) that sparked conversation and competition. Our social also included our AGM and the presentation of our section awards. And just like an in-person event, some people were so interested in the conversation that they stayed on the call after the program ended. In light of the success of this event, we will definitely be doing another online social in the future.

K-12 STEM Outreach

Building on the success of our classroom outreach in 2019, we had planned to do another session this year, but this was cancelled due to the pandemic.

Diversity and Inclusion

As discussed, our section maintains a close relationship with our student chapter at the University of Alberta and provides free luncheon registrations for students to help them network with industry professionals. We're especially pleased that the winner of our NextGen award was also previously in a leadership position with the student chapter.

Our Section Board has traditionally been young and diverse and 2020 was no exception. Although the Board has only five members, it once again included representation from Public Agencies, women, and younger members (under 35 years old). Including planners on the Board has been difficult as many planners commit their time to APPI, however, many of our events are well attended by planners and others who are not professional engineers. Acknowledging the need to broaden the Section beyond engineers, five of our seven presentations in 2020 included at least one speaker who was not an engineer, and two of the presentations had speakers from public agencies.

We had originally planned a joint event with APPI in April with a presentation from Dr. Karen Lee about opportunities for collaboration between transportation and health professionals. Unfortunately, this event was cancelled due to the pandemic but we are working to reschedule her for 2021.

Funding Support

In most years NACITE has a sponsorship program where companies can sponsor a luncheon or other event and recommend a speaker/topic. This has proven to be an excellent way to find unique topics that the board might not know about, in addition to providing additional funding for the Section. This funding helps support our student chapter, reduce registration costs at events, and provides the flexibility to try different new things where we may not be able to recover costs. For the 2019-2020 season (from Sep 2019 to Aug 2020) we raised \$3,400 from eight different companies. We decided not to call for sponsors for the 2020-2021 season due to the limit on events (and expenses) caused by the pandemic, but intend to resume the practice in 2021-2022.


